Life couldn't get much sweeter for former Kansas State University football player Nick Leckey.

While pursuing a degree in hotel and restaurant management on campus, the NFL came calling. Leckey was 30 credits shy of his degree, having taken his last semester off to train for the NFL scouting combine.

After wrapping up his sixth year as an offensive lineman for the New Orleans Saints, he signed up for Second Wind, a program that helps former K-State athletes finish their degrees online.

"The technology is the only way to do it if you have to work and you're out of state, like me," Leckey said. "You don't have to be in two places at one time. You go at your own pace. It's worked out great for me."

K-State's site-based master's program in Adult and Continuing Education has been offered for more than 25 years in several Kansas communities and has more than 1,000 graduates to date.
